I understand that this is a legal document and that by signing it I am giving up substantial legal rights and giving up my right to sue or otherwise make a claim against The Boys & Girls Club of Assabet Valley, its officers, boards, committees, employees, agents, volunteers, and contract employees. I further understand that my/my child's participation in these programs is voluntary. By signing this Form, I affirm that I have decided to allow myself/my child to participate in the recreation program's field trips with full knowledge that the Releases will not be liable to anyone for personal injuries and property damage I/my child may cause or sustain.
